POLICY FOR RENTAL OF TODD STADIUM & PARKING LOT

Todd Stadium may be used for community activities in accordance with this policy and implementing procedures approved by the Superintendent. It is the School Board's intent that Todd Stadium be used primarily for youth-serving activities although community activities are also permissible. Permission to rent Todd Stadium will only be granted to residents of Newport News, members of the Virginia High School League, colleges and universities (public and private), or other local governmental agencies.

If there is an admission charge for other than athletic events, a collection of donations, or the use is one for fundraising, the money or funds charged, collected, or raised will be dedicated to educational, charitable, civic, or community purposes; and no money or funds so charged, collected, or raised will result in any private or commercial gain.

Todd Stadium will not be used by any group or organization for any purpose that is inconsistent with the laws of the United States of America, The Commonwealth of Virginia, and/or the City of Newport News. Neither will it be used by any group or organization reported by the Attorney General of the United States, a communist-faction or a communist front organization.

Permission to use Todd Stadium will not be granted to any group or organization when the superintendent or designee, with the advice of the chief of police, deems there is imminent danger of any breach of the peace, turmoil, riot, or resistance of law and order, or danger to the school property of persons using the same.

No meeting or other activity shall be held at the stadium other than that stated in the application.

The School Board reserves the right to revoke a permit at any time by refunding the fees paid, less any expenses incurred.

Application for such use must be made on a form secured by the Director of Athletics and Driver Education, and the application must be signed by the Director of Athletics and Driver Education. The application will be approved by the Director of Athletics and Driver Education and the basic charge paid in advance. Newport News Public Schools retains the right to not approve applications filed with the Director of Athletics and Driver Education within fourteen days of the date for the requested use of the property.

Liability for damage to or loss of school property while it is being used by non-school groups is assumed by the applicant and the application will state the applicant agrees to assume such liability. The applicant must agree to protect, indemnify, and save harmless, the School board of the City of Newport News, its officers, and employees from any and all claims, liabilities, damages, or rights of action directly or indirectly growing out of the use of the premises by such community organization.

In order to afford some protection for citizens who may become injured on school premises while attending or participating in functions by non-school groups, Newport News Public Schools require users of Todd Stadium/administration building parking lots to carry a commercial general liability insurance policy with a limit per occurrence of \$1,000,000. A policy certificate of such coverage will accompany the application.

All stadium and parking lot concessions will be operated by the school board and the profits received from the operations will remain with the School Board. Alcoholic beverages are prohibited on school board property. Smoking is prohibited per school board policy.

CHARGES

When used for any activity for which **admission is charged, the basic fee will be 10% of gross ticket sales receipts or \$750 whichever is the greater amount.** This fee will include the following facilities, equipment and personnel:

- Field
- Track
- Dressing Rooms
- Restrooms
- Officials' Room
- Press Box
- Scoreboard
- Hurdles
- Jumping Standards, Crossbars, etc.
- Landing Pits
- Usage of Public Address System

Javelins are prohibited at Todd Stadium.

The full rental payment is due seven (7) days prior to the event

When used for an event for which **admission is not charged, the basic fee will be \$500.** The fee for the use of the Todd Stadium track for practice by organized teams is \$200 per practice. Supplemental charges, as stated above, will remain the same. Certain events may be classified as special rentals by the Assistant Superintendent for Business and Support Services, in which case the base rental fee may be adjusted on an individual basis.

TODD STADIUM/ADMINISTRATION BUILDING/PARKING LOT

The procedure for the use of the Todd Stadium/Administration Building parking lot when Todd Stadium is not being rented requires the same application procedure which is used for the rental of Todd Stadium. Whenever the parking lot is used, the same insurance provisions apply as when renting Todd Stadium. The rent for the parking lot shall be \$300.00 per day.

If there is a required set up of traffic cones and/or the moving of school board vehicles, the rent for the parking lot shall be an additional \$50. The rent for using traffic cones is \$25 when school division personnel are not used to set up the traffic cones.

The Director of Athletics and Driver Education will determine the number of police required.

There may be other charges as determined by the Assistant Superintendent for Business and Support Services.
