

Job Title: Supervisor II, School Security & Supervisor: Executive Director, Secondary School Leadership

# Job Summary

Position is responsible for developing, organizing, and managing the division's school safety and security program and emergency management operations. Position establishes and interprets security policies and procedures; evaluates the security program; prepares a budget; and develops a training program that meets or exceeds state requirements and industry best practices. Position develops and maintains division crisis and emergency plans; and as the senior division representative, leads all involvement with the Newport News Division of Emergency Management, to include planning and executing division response before, during and after disasters, emergencies and drills.

## **Essential Duties**

- 1. Administers security policy, procedures and programs to ensure effective and professional security operations throughout the division
- 2. Is the primary school division representative for all city emergency management operations and functions, including serving in the Emergency Operations Center during disasters and crises
- 3. Coordinates with Principals to manage all school-based security officers
- 4. Determines any special security needs for public meetings or division-wide activities
- 5. Manages the hiring, training, assigning and evaluating of all security personnel
- 6. Works with the Purchasing Department to acquire security equipment that is appropriate to the needs of the schools and the division
- 7. Produces an ongoing staff professional development program for school security personnel that meets or exceeds state mandates and industry best practices
- 8. Develops procedures and protocols to prepare for, prevent, respond to and recover from emergencies and maintains the division Crisis Management Plan
- 9. Serves as the Unit Anti-Terrorism Officer for General Stanford Elementary School as required by Air Force and Army regulations
- 10. Administers the Security department budget
- 11. Identifies legal issues or concerns and researches and implements solutions
- 12. Serves as the project manager overseeing the maintenance, repair and development of the division's camera surveillance system
- 13. Serves as the primary school division liaison with local, state and federal public safety agencies on all matters related to school safety
- 14. Researches and applies for appropriate grant opportunities
- 15. Serves as the division "Contact Person" for the Department of Criminal Justice Services School Security Officer Database
- 16. Participates in training and professional development to increase individual skills and proficiency related to the assigned duties
- 17. Develops and implements prevention strategies in an effort to minimize the likelihood of school violence
- 18. Makes presentations to various community groups and organizations about school safety and security
- 19. Serves on committees, task forces, and special projects as assigned
- 20. Models nondiscriminatory practices in all activities

#### **Other Duties**

- 1. Initiates and maintains effective liaisons with other school divisions, public safety agencies and professional societies to maintain a current knowledge of developments and research in the profession.
- 2. Performs and other related duties as assigned by the Executive Director, Secondary School Leadership

## **Job Specifications**

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. ## Minimal Qualifications (Knowledge, Skills, and Abilities Required)

Bachelor's degree from accredited college or university required (Master's degree preferred). Degrees in Criminal Justice, Security Management, Homeland Security or a related field preferred. Certification as CPP is required within one year of the date of appointment. Additional certification in Emergency Management is preferred. Ten or more years of senior security or law enforcement leadership experience is required. Comprehensive knowledge of security management principles, best practices and related laws and policies required. Demonstrated ability to advise internal and external customers on matters of safety and security required. Demonstrated strong computer skills in MS Office 2007/XP required. Valid Virginia driver's license with a positive point balance required.

# **Working Conditions & Physical Requirements**
