

# **Approved Courses to Satisfy the Special Education Prerequisite Coursework**

The following courses have been identified to meet the minimum competencies of foundations for educating students with disabilities and an understanding and application of the legal aspects and regulatory requirements associated with identification, education, and evaluation of students with disabilities. These competencies must be completed **prior** to the issuance of a special education provisional license in Virginia.

Below is a list of Virginia's institutions of higher education with VDOE-approved teacher education preparation programs, offering endorsements in special education. Please read and advise carefully as some institutions offer different options and some may require a combination of two courses.

This is not an exhaustive list of accepted courses that satisfy the prerequisite requirement for a special education provisional license. The Office of Licensure and School Leadership advises candidates to enroll in an approved teacher preparation program. 
